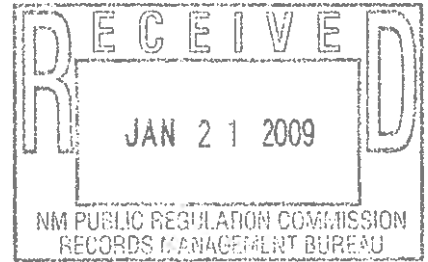

DESCRIPTION OF SUPPLY SYSTEMS

The gas distributed by the Company in all of its service areas is furnished from the transmission systems owned and operated by the Company or its suppliers:

Northwest Supply System: That system of transmission pipelines and related equipment and facilities which is supplied from various wellhead and plant outlet sources in the San Juan Basin of northwest New Mexico and by certain city gate purchases from El Paso Natural Gas Company's Southern Division System in or near Belen, Gallup and Grants and/or from the Transwestern Pipeline Company's System, which provide gas for customers in the areas serviced by the following Company offices:

Albuquerque	Gallup
Belen	Grants
Espanola	Santa Fe
Farmington (except Fruitland/Kirtland)	Taos

Southeast Supply System: That system of transmission pipelines and related equipment and facilities which is supplied from field line and point outlet sources in the Permian Basin of southeast New Mexico, which provide gas for customers in the areas serviced by the following Company offices:

Artesia	Lovington
Carlsbad	Roswell

El Paso Natural Gas Company's Southern Division (Interstate) System: That group of purchase points (city gate) owned and operated by El Paso Natural Gas Company, which provide gas for customers in the areas serviced by the following Company offices:

Union County Supply System: Those purchase points (city gate) owned and operated by West Texas Gas Transmission Company, which provide gas for customers in the area served by the Company's Clayton office.

Brazos Supply System: Those purchase points (city gate) owned and operated by Brazos Gas Transmission Company and any other sources from other suppliers which may be connected, which provide gas for customers in the area served by the Company's Chama office.


